

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.grayce.us, and Grayce Property Consultants LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Grayce Property Consultants LLC include www.grayce.us and Grayce Property Consultants. The Grayce Property Consultants website is a Commercial Real Estate site. By using the Grayce Property Consultants website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Grayce Property Consultants may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Employer
- Job Title
- Any information freely entered by users

Grayce Property Consultants may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. Use of your Personal Information

Sharing Information with Third Parties
